Implemented. Participated in meeting about NAP III of OGP which was held in August 2018 and BO related activities are being included in the NAP III. Implemented. In May 2018 we organized a summit with the Parliament and the Government representatives and other stakeholders.

Implemented. In February 2018, we organized a consultative meeting in cooperation with the Ministry of Mining and heavy industry with the executive officers of government authorithies that register BO information.

In progress. A draft law on amending the related laws was drafted and presented to Member of Parliament B. Munkh-orgil in June 2018. he is getting the opinions of the State registration authority

Implemented. The terminology was approved during the MSWG meeting in November 2017.

In progress. A manual was prepared and printed about the international experience on BO disclosure Implemented. The research report was published in December 2016.

Implemented. In total 3 meetings were organized in February, April and May 2017 with 88 participants. The participants' opinion were asked. Implemented. Consultative meetings were organized in Cooperation with the Ministry of Miniing and heavy industry in February and June 2017 and 51 participants' opinion were asked.
