



**Education in a prestigious Russian university in Altai**  
**Financial University turned 100 years old on March 2, 2019!**

**The Altai branch of the Financial University** is a branch of the Federal State-Funded Educational Institution “Financial University under the Government of the Russian Federation”. Its founder is the Government of the Russian Federation.

In Altai, the Financial University trains specialists in the field of economics, finance and management for state and commercial organizations. **The branch was founded in 1965**. The Financial University has 28 branches throughout Russia. The Altai branch is geographically advantageous for citizens of China and Mongolia. All over Russia branches of the Financial University conduct training according to single programs; a state-recognized diploma of the head university of Moscow is conferred. Meanwhile the education fee in Altai compares favorably with the education fee in the cities of the Central part of Russia. The Financial University uses **advanced educational technologies**, it also has an information and educational portal and e-library systems with remote access via the Internet.

Classes are conducted by teachers, 86% of whom have scientific degrees; 88% of Academic staff are full-time employees; 12% - managers and specialists of the real sector of the economy and finance, among which there are graduates of the branch. **The University is proud of its graduates** who work in **federal government institutions**: A.G. Khloponin, Deputy Chairman of the Government of the Russian Federation; A.G. Siluanov, Minister of Finance of the Russian Federation; S.V. Stepashin, Director of the Federal Security Service of the Russian Federation (1994-1995), Minister of Justice of the Russian Federation (1997-1998), Minister of the Interior of the Russian Federation; in **regional institutions**: V.M. Kostina and M.N. Korablev, Head and Deputy Head of the Federal Treasury for the Altai Territory, respectively; T.M. Vinokurova, head of the Altai Departments of the Central Bank of Russia; V.M. Loktusheva, head of the Altai branch of the Russian Union of Entrepreneurs and Industrialists; A.I. Makulov, Counsellor to the Chairman of the Management Board, member of the Board of Directors of AO KB “ForBank”; A.N. Stepanov, Head of the State inspectorate of the Altai region; B.A. Trofimov, Head of the Main Department of the Pension Fund of the Russian Federation in the Altai Region and others. Cheng Wei, the Rector of the Liaoning University (Shenyang, China) also is a graduate of the University.

The branch cooperates with foreign universities, for example, with Czech university the Central Bohemia University (CBU) (Czech Republic), with the Kazakh Humanitarian Law Innovative University (East Kazakhstan region, Semey), with the Kyrgyz-Russian Slavic University named after the first President of the Russian Federation B.N. Yeltsin (Bishkek, Kyrgyz Republic).

All programs are taught **in Russian**.

At the moment, the University implements the following programs and concentrations:

**Bachelor degree programs:**

- “Economics” (concentrations: “Accounting, analysis and audit”, “Economic security of business entities”, “Finance and credit”);
- “Management” (concentrations: “Financial Management”, “Management of the organization”);
- “Business Informatics” (without a program concentration).

**The term of study** for Bachelor degree programs is **4 years** for face-to-face mode, **4.5 years** – for off-campus/on-campus, correspondence mode.

**Master degree programs:**

- “Economics” (“Accounting, analysis, audit”);
- “Management” (“Financial Management and Capital Market”, “Innovation Management and Entrepreneurship”).

**The term of study** for Master degree programs is **2 years** for face-to-face mode, **2.5 years** – for correspondence mode.

The tuition fee for one academic year of Bachelor degree programs: 99,900 rubles for face-to-face mode, 49,646 rubles for correspondence mode.

The cost of training for graduate programs for one academic year in absentee form - 53 000 rubles.

The tuition fee for one academic year of Master degree programs is 53,000 rubles for correspondence mode.

If you have a diploma of vocational education (college, university), in Altai you can take advanced training courses - **additional education** programs at the Financial university.

Students are provided with an accommodation in double rooms of a comfortable dormitory, located within walking distance from the academic buildings. The dormitory has equipped kitchen rooms, laundry rooms, drying and ironing rooms, there are training rooms, a gym, Wi-Fi. The accommodation fee for students studying on a fee-paying basis was 1202.06 rubles per month in the 2018/2019 academic year.

There is a **visa support** for foreign students.

## **SCHEME FOR ADMISSION TO THE ALTAI BRANCH OF THE FINANCIAL UNIVERSITY**

### **1. Prepare and submit documents do 20 iyulya.**

The list of necessary documents for admission to the training of foreign citizens:

1. Filled in [application form](#) with a color photo attached.
2. Copies of education certificates accompanied by an academic transcript with a list of courses taken and grades (points) obtained. If because of the educational process organization's peculiarities in a foreign country the foreign national who applies for enrolment to programs of secondary vocational or higher education programs does not have a certificate of foreign education or qualification, the foreign national should submit a document containing information about the results of the latest tests passed issued by an educational establishment where the person was trained on the territory of the country of origin.
3. A copy of a medical certificate (form № 86) issued by an authority that operates in the country of origin that proves that there are no counter indications to training on the territory of the Russian Federation.
4. A copy of an HIV/AIDS certificate issued by an authority that operates in the country of origin.
5. Copies of the passport pages that will be shown to border officials when entering the territory of the Russian Federation. The passport expiry date should not be later than 18 months of the date of issue of the student visa (clearly readable pages containing the personal data for the invitation).

Documents are **submitted in person** at the address: room 605, 610, 54 Lenin prospect, Barnaul, Altai Region.

### **2. Pass admission exams in writing (testing) in the following subjects: mathematics (specialized), Russian language**
